

Pickleball

There are four pickleball courts at Cottonwood for Cottonwood Palo Verde homeowners, guests, renters and associate members. The courts have lights for night time play.

The Sun Lakes Pickleball Club (SLPC) members are granted exclusive use of the courts for 6 hours a day Monday thru Friday. Their summer hours are May 1st to September 30th from 7:00 a.m. to 11:00 a.m. Their winter hours are October 1st to April 30th from 8:00 a.m. to 2 p.m. The SLPC also has tournaments throughout the year when the courts will be unavailable for play.

The courts are open the remaining time to Cottonwood Palo Verde homeowners, guests, renters and associate members for summer hours are May 1st to September 30th, Monday to Friday from 11:00 a.m. to 9:00 p.m., Saturday and Sunday from 7:00 a.m. to 9:00 p.m. The winter hours are October 1st to April 30th Monday to Friday from 2:00 p.m. to 8:00 p.m., Saturday and Sunday from 8:00 a.m. to 8:00 p.m. CWPV Residents may bring guests to play pickleball ONLY during HOA Open play times, on a one-to-one basis.

HOA open time (non-club time) players desiring a court must sign up on the chalkboard with their full name, the number of players in their group and start time. If all the courts are in use, reservations for the next available court may be made by signing up on the chalkboard located by the pickleball courts. The court letters have no significance on the chalkboard. One player must stay in the sign up area. If the full group is not present and ready to play when the court is available, then the court must go to the next group that is all present.

Playing time is limited to one hour for singles and doubles. Groups playing prior to a previously scheduled event must leave the court at the start of the event unless there is no one else signed up.

Facilities Dress Code

All Pickleball players using the courts must comply with the HOA dress code and footwear code. Shirts and non-marking shoes, tennis or court shoes, must be worn at all times. Tank tops, swimwear, midriff exposing tops and cutoffs are not considered proper attire.

Reciprocal Agreement Policy

The SLPC membership is limited to thirty-five Non CWPV residents during any calendar year. Residents of Sun Lakes Country Club, IronOaks, and Renaissance may purchase an annual membership at the Recreation department at a set rate by the HOA. The rate set by the HOA may vary, depending upon the existence of reciprocal agreements.
